**TRUST UNIFORM POLICY**

**Approved by the Board of Trustees – July 2026**

**Next Review Date – July 2027**

The wearing of full Trinity Academy Newcastle Trust (The Trust) uniform is expected as an integral part of The Trust ethos which promotes positive attitudes, high standards and a sense of personal pride and identity. Uniform can also be useful to protect children from social pressures to dress in a particular way. We try to adopt a sensible attitude towards The Trust uniform, and we do not expect parents to spend a great deal of money on The Trust uniform.

### **The Trust uniform**

- Academy white polo shirt (Available at cost from Academy reception)
- Academy navy blue jumper (Available at cost from Academy reception)
- Plain black or grey trousers or skirt below knee - widely available (including from low-cost outlets)
- Plain black flat shoes - widely available (including from low-cost outlets)
- PE Plain black trainers - widely available (including from low-cost outlets)

The Trust uniform with logos can be ordered from the site admin office. Learners may wear clothes described above without The Trust logo but these must be plain and free from all other logos. Please direct all enquiries to the site admin office.

Requirements for The Trust dress are based upon a consideration of ethos, neatness, cleanliness and suitability for work at The Trust. We strive for excellence and the policy towards uniform to be in keeping with this, with an expectation that learners take pride in their appearance and in their Trust. Each learner should be able to move freely without the restriction of unsuitable clothing.

For these reasons we expect each parent to take responsibility for ensuring that their child is dressed in accordance with The Trust's dress code.

### **Second hand Uniform –**

The Trust promotes a second hand uniform scheme, Parents and carers are encouraged to recycle uniforms. Uniforms are stored within each Academy/site reception, cleaned, ironed and presentable. Second hand uniform is free.

### **Requests to support**

With the rising cost of living, any uniform concerns should be directed in the first instance to the Academy Head of School, The Trust adopts a proactive and supportive stance

### **Other items**

Jewellery - One wrist watch is acceptable. Students with pierced ears will be allowed to wear two plain gold/silver small studs. Diamanté, crystals, gemstones or other decorative styles are not acceptable

Make up - Students are not allowed to wear make-up at the lower school. At the upper Trust learners are permitted to wear minimal, discrete makeup. Nail varnish or nails are not permitted.

## **Non-observance of Uniform Policy**

It is a requirement that all learners wear correct Trust uniform.

A repeated failure to do this will lead to consequences for the learner, and ultimately inconvenience for the parent.

1st occasion – A reminder from the form tutor

2nd occasion – A telephone call to the parent

3rd occasion – Parent will be requested to bring in appropriate uniform or learner sent home

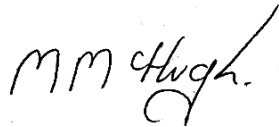
If there is a genuine reason for not wearing the correct uniform then please send your child to The Trust with a note detailing the reason and the length of time until it can be rectified.

## **Non-school uniform items**

Non-school uniform items such as coat/hat/scarf/gloves etc. are to be removed/handed in before entering any classroom or form of assessment / Exam room.

Specific Non-uniform items may be worn at the discretion of the Head of School where a need or an exceptional circumstance has been identified (EHCP etc.). None uniform items which have been approved by the Head of School will be searched prior to entering an assessment or exam room.
